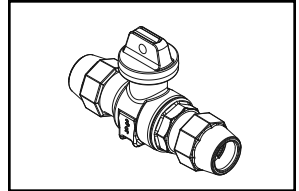
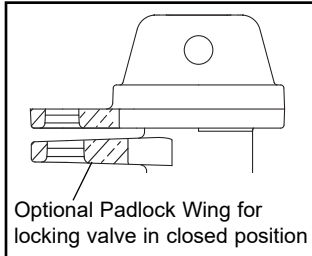


SUBMITTAL INFORMATION

Ball Valve Curb Stop - (B44-xxx-G-NL style)



GRIP JOINT FOR COPPER OR PLASTIC TUBING (CTS) INLET AND OUTLET



Solid one piece tee-head and stem

Sturdy stops allow 90° motion and are enclosed and protected

Dual EPDM O-rings in the stem

Phosphor Bronze Gripper Ring for axial restraint

A snap ring locks the stem into the body of the valve

Molded EPDM rubber seat with reinforcing ring supports the ball

Grip Joint Nut

Nylon Washer

Beveled EPDM rubber gasket provides hydraulic seal

- Brass components that do not come in contact with potable water conform to AWWA Standard C800 (ASTM B62 and ASTM B584, UNS C83600, 85-5-5-5)
- Valve is non-directional and is watertight with flow in either direction
- Ends are integral or secured with adhesive to prevent unintentional disassembly
- Hole for attaching curb box rod or handle is provided in tee-head
- 300 PSI working pressure

Optional Padlock Wing for locking valve in closed position. Insert "W" into part number. Example: B44-444W-G-NL

Optional full 360° tee-head rotation. Add "R" to end of part number. Example: B44-444R-G-NL
